## Concept elaboration

- ▶ Statistics Estonia has responded to the need of data on disabled population
  - ▶ Initiative from Ministry of Social Affairs from 2008 to monitor different aspects of quality of life of those who are officially receiving benefits
    - ▶ Task to link data from Social Insurance Board of those with profound, severe or moderate disability or incapacity to work (40-100%) with data collected at the individual level in other sources (with LFS data since 2008, not published)



## Concept elaboration

- ▶ Wider need to monitor the participation of different minorities (e.g. by immigration, disability etc) in the society has led SE to increase details in published data since 2008 ( e.g. LFS disabled population [http://pub.stat.ee/px-web.2001/I\\_Databas/Social\\_life/09Labour\\_market/090Health\\_and\\_ability\\_to\\_work/090Health\\_and\\_ability\\_to\\_work.asp](http://pub.stat.ee/px-web.2001/I_Databas/Social_life/09Labour_market/090Health_and_ability_to_work/090Health_and_ability_to_work.asp); for immigrant population [http://pub.stat.ee/px-web.2001/I\\_Databas/Social\\_life/09Labour\\_market/102Immigrant\\_population/102Immigrant\\_population.asp](http://pub.stat.ee/px-web.2001/I_Databas/Social_life/09Labour_market/102Immigrant_population/102Immigrant_population.asp))
- ▶ Facilitated by the general need, agreed at Eurostat level to get data on health and social integration of population (see Meltzer, H. presentation) : EDSIM not approved at country level, instead EHIS-> ESHSI, countries responding to find alternative ways in between years)

## Concept elaboration

- ▶ Statistics Estonia 2010 started a working group to agree upon the data and sources to facilitate monitoring these indicators
- ▶ Working Group: social director of SE, Ministry of Education and Research, Ministry of Social Affairs, ANED representative, National Institute for Health Development

## Concept elaboration

### ▶ Main aim:

- ▶ To relate data from Social Insurance Board and self-definition on activity limitations on all data sources (except on those from administrative data) and compare groups defined as with disability, incapacity to work and activity limitations with total population on main aspects of integration into social life and quality of life
- ▶ Discussions: age profiles (needs for policy management (18-63) vs comparability needs (20-64); reasonability (survey data: education 25-39), definitions – special needs vs disabled

## Results

- ▶ Agreed on 7 main topics and monitored feasibility of proposed indicators:
  - ▶ Profile and structure of disabled population
  - ▶ Personal and Family life
  - ▶ Choice and control (mainly administrative data)
  - ▶ Access to goods and services
  - ▶ Education and life-long learning
  - ▶ Work and employment
  - ▶ Income and poverty

- ▶ 2014 – analytical publication ‘Quality of life and social integration of disabled population’
