

# Rural Development Programmes 2014-2020: Key facts & figures FOCUS AREA 2B: Entry of skilled farmers into the agricultural sector

#### 1. Introduction

**Focus Area (FA) 2B** is designed to facilitate the entry of adequately skilled farmers into the agricultural sectors and in particular young people.

Through this focus area, Managing Authorities are able to provide young farmers with support for start-up aid and investments together with advice, training, cooperation and knowledge transfer.

The aims of this focus area are to:

- Encourage a generational change in the agricultural sector.
- Enhance the competitiveness of the agricultural sector through new and innovative ventures;

The target is to mobilise 10.4 billion EUR of public and private investment to support 176 000 farms.








