### BACKGROUND

In 2019, the Managing Authorities (MAs) of RDPs will submit the second enhanced Annual Implementation Reports (AIRs), which will also include reporting on the progress towards the programme's objectives and on the programme's contributions to achieving the Union's Strategy for smart, sustainable and inclusive growth. This will be done through the assessment of the programme's net contributions to changes in the CAP impact indicator values, and through answering the relevant evaluation related questions. Estimating and netting out of the environmental effects of the RDP can be a challenging exercise for many reasons, including scarce data availability and establishing the counterfactual. Moreover, capturing and upscaling environmental effects can be methodologically very demanding.

### OBJECTIVES

- Show and discuss practical examples of evaluation approaches for assessing the environmental related CAP Pillar II impact indicators and for answering the related Common Evaluation Questions (CEQ) in 2019.
- Identification of specific challenges related to the application of the presented evaluation approaches covering CEQs 24, 26, and 28.
- Exchange experiences among Member States and develop recommendations for evaluators and Managing Authorities to facilitate the use of robust evaluation methods for assessing RDP environmental related impacts.
