#### Sixth Report on Economic, Social and Territorial Cohesion (July 2014, 298 pages)

Looking ahead to 2014-2020, the report outlines how investments will be focused on key areas like energy efficiency, employment, social inclusion and SMEs to get the most of the investments to the benefit of citizens.

The Report analyses the state of cohesion of the Union and highlights the challenges faced by national, regional and local authorities in overcoming the impact of the financial and economic crisis. In particular it finds that Cohesion Policy has cushioned the dramatic decline of public investment, injecting much needed investment resources in many Member States and creating vital financial stability which serves to attract private investment.




#### Eighth progress report on economic, social and territorial cohesion (June 2013, 40 pages)



Science and technology park (STP) activity across the EU has approximately doubled over the last 11-12 years, driven by the growth of the longer standing parks and the emergence of new parks. There is now an estimated 366 STPs in the EU member states that manage about 28 million m2 of completed building floor space hosting circa 40,000 organisations that employ approximately 750,000 people, mostly in high value added jobs. In the period from 2000 - 2012 total capital investment into EU's STPs has been circa €11.7 billion (central estimate)






#### Urban Development in the EU: 50 Projects supported by the European Regional Development Fund during the 2007-13 period (March 2013)




#### Quality of life in cities; Perception survey in 79 European cities (October 2013, 151 pages)



The Travel Book is a multilingual and fun tool (700 stickers) - it's about Europe (flags, countries, capitals, rivers etc.) and you can learn more about the role of the European Union. The pages for the Member States include links to websites, including Representation. Last but not least, the introduction and the text on EU diversity are both available in all 24 languages.




